As an NGO CDP collects climate information data from thousands of the most market-listed companies worldwide. In the yearly CDP survey, companies respond to questions around carbon emissions, climate related chances, risks and corporate reduction strategies. CDP is regarded as one of the primary drivers for sustainability impact assessments. CDP ratings are incorporated in financial ratings as on the Deutsche Börse, Reuters or Google Finance.

Due to the transparency of the rating and its publication, a natural competition evolves. The total number of corporate participants in the CDP survey is steadily growing. CDP follows the holistic approach to incorporate not only direct emissions but also emissions along the life cycle of products and services. This involves also data from the supply chain partners. With its Supply Chain Program, participating companies can invite their partners along the supply chain to join the initiative.





CDP response check

Response check is a high level 'checking' service for CDP responding companies that have completed their 2014 CDP response. Prior to final submission to CDP, an external check can now be performed to ensure the response is as complete as possible. The Response Check service can be delivered by DFGE, who have received training from CDP on the response check methodology and process.

We also support you on any other realization or review of your internal carbon footprint calculation. E.g. to carry out a focused calculation for scope 1+2 emissions only or to analyze a certain category as logistics.



The calculation of the carbon footprint follows the DFGE TopDown Approach according to the GHG Protocol. This allows us to conduct the carbon footprint calculation within a short time frame .

Based on an overall analysis the DFGE focuses on the sensitive positions (hot spots). In an iterative-recursive process, the corporate balance and hot spot calculation is honed and the reliability increased.

In every step the band width is also reduced. To limit the efforts in data collection and to automate initial accounting the DFGE uses the software application FridaCarb.
